4. Chairman's Report

3. Treasurer's Report

Prior to the meeting a summary of the accounts had been distributed by email to all members with the AGM papers. There were no questions from the members on the accounts. The chairman thanked Shirley Isseyegh, the Treasurer, for keeping the accounts in good order. The Treasurer said that when she took over the accounts last year, they had been kept manually on paper since the inauguration of the Eastern Alpaca Group. Since taking over, she had computerised the current year's information and she was hoping to also computerise the historical data so that comparisons can be made. She

thanked Sally Berry for doing the audit of the accounts for us. The membership had remained balanced at 38 members. The Group was in a good position with the bank balance but the Chairman said that a good sized reserve was needed to put a Halter Show on. The committee had made the decision to minimise costs on the Fleece show and keep the entrance fees very low and not to ask farms for sponsorship in recognition of the very tough year experienced by farms because of Covid-19 – as a result the fleece show had made a very small loss, which would be shown in next year's accounts.

4. Appointment of Auditor

It was agreed to ask Sally Berry to audit the acounts next year.

5. Committee Member

The chairman said that the committee members were willing to continue but had requested volunteers to join the committee to help out as we are all very busy. Kath Shearer had volunteered and was appointed. As a committee we are trying to distribute more information to members via email, newsletter, website and facebook.
